The Charitable Trust is currently seeking to appoint new Trustees.

The Trust is governed as an unincorporated association in the name of The Manchester High School for Girls (MHSG) General Charitable Trust operating as the MHSG Bursary Fund. The Trustees play a vital role in ensuring that Trust achieves its core purpose and has a clear strategy.

Manchester High School for Girls is closely connected to the Trust and is one of the leading independent girls' day schools in the country, providing an excellent educational experience for four to 18 year-olds. Founded in 1874, the School has a long and distinguished history and made a pioneering contribution to the development of women's education. All three of Mrs Pankhurst's daughters were educated here. The School takes its inspiration from its traditions and continues to produce students who distinguish themselves in many professions, becoming role models of successful and influential women. The character of the School has also been shaped by its accessibility to girls from a wide variety of social, cultural and religious backgrounds so that a diverse community has developed which both values individuality and promotes tolerance.

The Trust provides essential support to the advancement of the educational work of the School by providing means tested bursaries to students who have performed well in the entrance examinations and interview for entry into Year 7, and GCSE results for Sixth Form. The work of the Trust is essential to achieving the School's objective of becoming increasingly socially diverse regardless of the financial means of parents and as the girls' school of choice across the North West. The Trust is also able to fund capital projects if the donor or Trustees decide.

A small number of part or full fee bursaries are offered to pupils who can demonstrate the need for financial support as well as academic potential. The School is aiming to award more transformative bursaries designed to support those with the greatest financial need, ensuring they can truly benefit from a life-changing MHSG education. The School works hard to ensure bursary funding is awarded to those who would benefit most from an MHSG education.

### **Organisational Management and Decision Making**

The Trustees determine the strategic direction and general policy of the Trust. The Trustees normally meet twice a year, at the School, covering operational, tactical and strategic issues. The day-to-day administration of the Trust is provided by the School. Regular meetings are held with the investment advisor and the School continues to seek to develop its relationship with local organisations and former pupils to increase the level of donations and legacies.

## **Objectives**

The focus continues to be to build up and maintain adequate funds to sustain the level of bursary support provided to pupils at the School. The Trustees actively seek ways to enhance the underlying capital of the Trust to maximise the possibility of future awards.
